FILM SHOOT PREPARATION & REMINDERS

To help you and your child have the best experience on shoot day, here are a few tips and reminders: Bring your **imagination**! Think about the kind of character you'd like to play - you can choose to be a **protagonist (good character)** or an **antagonist character)**. Costumes are **optional** - bring one if you'd like, or come as you are. Even simple accessories can add to your character. Bring a **jacket** or sweater, since it may get chilly in the evening. Consider bringing an **extra pair of shoes** in case it gets muddy or uncomfortable. A **flashlight** can be fun and useful, especially as it gets darker later in the evening. **Snacks and water will be provided on-site**, but they may be limited and simple. Please feel free to bring **extra snacks** if you'd like more variety or have special favorites. You may also bring **props** if you want to enhance your character - nothing too large or difficult to carry, just items that add to the fun
